#### Principal's Report

Many things to mention but not a lot of time.

Thank you to Lynne and P&C as we have been awarded the grant for \$38000 for our Gardening Club expansion. Gardening club is very popular with the students at school. Eleni Petinos has mentioned our school in parliament relating to this grant. The school will contribute the rest of the money needed for the project. We will be renovating the area in front of the Year 6 classrooms; this will make the area more attractive. We are putting in an Amphitheatre. This will be used for tasting food and small performances. It will be built into the natural slope of the land. Eleni Petinos was at the school today taking photos.

In other areas of maintenance, we will be upgrading the school toilets. If there is extra fundraising money, we would like some support from the P&C. Currently getting quotes. This will be a 12month project.

Michael Brown has previously requested smart boards; this time we are looking at more STEM based resources i.e., chrome books.

Many know our previous Chaplin Jessie Morson left at the end of last year. He didn't leave because he wanted to. He and his wife recently had a second baby and 7 days work was too much. He is now working 5 days a week at a high school. We have been looking into someone else. We are in touch with 2 organisations to find the right person for the job. Chaplin is (student wellbeing officer) a name that was given however they do look after student wellbeing. Play games with the children at lunchtimes.

As a staff we have been discussing changing bell times. We are one of the latest schools in the Sutherland Shire. Our bell times are not in line with PSSA and children are being dropped to school way too early. The teachers are in favour, so this is now being brought to the P&C.

Feedback from parents at the meeting was in favour of the change.
