SCHOOL PLAN FOR 2015-2017

Next Tuesday we have a random sample of parents (32) who have been selected and invited to participate in a discussion group next Tuesday morning from 9.30am in the library. The RSVP is this Friday so hopefully we will have a good turnout. If anyone would like to come next Tuesday morning at 9.30am they would be very welcome.

SCHOOL CAPTAINS

This program is cheaper to run than ENews and allows the school to send push notifications on smart phones.
